113th Convention Exhibit Preview Photographic Instructions for JAES, July/August 2002 Issue

General Information

The editorial staff uses Macintosh computers with MacLinkPlus (conversion program), Photoshop (graphics program), Zip drive, and CD-ROM drive.

Order of Preference for Submission of Photographic Material

1. black and white photograph, slide or transparency
2. color photograph, slide or transparency
3. electronic black and white or color photograph saved as an uncompressed TIFF or EPS file with a resolution of 300 dpi
4. CD-ROM containing a black and white or color photograph with a resolution of 300 dpi

Important Information

Electronic or CD photograph must not exceed a 3-inch square. Do not include text and photograph in the same file. Save photograph as a Macintosh file (if menu option available). Do not send more than one photograph in file. Do not send a (read-only) PDF file. All photograph files will be sent to an outside graphics house for processing. Because of a tight production schedule, the AES can not contact you if photograph can not be used with the text.

The photographic image will be reduced to fit into a 2-1/8-inch (54.0-mm) wide by 2-1/4-inch (57.1-mm approx.) high (maximum) ruled box for insertion with the exhibit preview text into a Quark 4.11 file for page layout.
